TOP TIP

Utilize all MAP-21 funding programs - including TAP, HSIP, CMAQ, STP, and Section 402 - to include biking and walking in all transportation projects.

FEEDBACK

- Remove restrictions on state transportation funds that disallow funding of bicycle facilities. Include bicycling and walking in any new Missouri transportation funding initiatives, with bicycling and walking receiving a fair amount according to mode share and percentage of injuries and fatalities.
- Adopt a safe passing law with a minimum distance of 3 feet or a 'move over for cyclists' law similar to the existing 'move over for emergency vehicles' legislation to address bicyclist safety.
- Adopt a vulnerable road user law that increases penalties for a motorist that injures or kills a bicyclist or pedestrian.
- Adopt an anti-harassment law that makes it unlawful to harass, taunt, or maliciously throw an object at or in the direction of any person riding a bicycle.
- Adopt a statewide, all-ages cell phone and texting ban to combat distracted driving and increase safety for everyone.
- Adopt a statewide Complete Streets policy.
- Adopt a statewide policy that requires bicycle accommodations on all bridge and tunnel projects.
- The state should spend a higher amount of federal funding on bicyclists and pedestrians. HSIP and 402 funding spent on bike/ped safety initiatives at minimum in proportion to bike/ped injury rates in Missouri. Adopt federal funding project rating criteria that incentivize bicycle projects and accommodations.
- Adopt a statewide bicycle plan that addresses each of the five Es, has clear implementation actions, and performance measures to gauge success.
- Do not adopt the proposed Bicycle Ban and Mandatory Sidepath Law. These types of laws are well intended but discourage people from riding.

The Bicycle Friendly States ranking is based on a comprehensive survey completed by state departments of transportation and state bicycling advocates. It asks comprehensive questions across 5 categories: Legislation and Enforcement, Policies and Programs, Infrastructure and Funding, Education and Encouragement, Evaluation and Planning. The results listed above provide only a snap shot of the full application. They are intended to offer some ideas for further growth in bicycle friendliness.
